## 3) New business

## a) Open discussion

A parent stated concern with team formation in regard to players moving from the U15 girls team to the U19 girls team. There are a few concerns, one is being able to field a competitive U15 team, a wide age range, and having enough players. Tony DePlata stated the Board's goal is, to try to form competitive teams in correct age divisions. This often presents difficulty due to our limited population and pool of players. But the Board continues to try and form age appropriate, competitive teams. (Teams are formed per CSA/USYS age requirements, which is based on birth year not school grade). Another concern was players moving from one team to another team midseason. There was a misunderstanding that a player was pulled up to an older team midseason. The Board typically does not move players midseason, and in the case of concern, the player was not "pulled" up and did not play on a different team midseason.

#### b) Board Member Discussion

Christine Levitt has formally submitted her resignation from the Board where she held the position of Treasure. – The Board has accepted her resignation and wishes to recognize her many years of service and huge contribution to soccer in Grand County. Christine will be missed.

#### c) Discuss financials

Financials were discussed. The Club was able to retain a small amount of excess with the amount of Player (traveling and Development) participation being just under a typical non-covid season.
